AT A SESSION OF THE ABOVE COURT HELD IN THE CITY OF BAD AXE, COUNTY OF HURON

PRESENT: Honorable Gerald R. Prill, Circuit Court Judge

Upon the stipulation of the parties, the Court finds and orders as follows:

- 1. On October 3, 2016, an email was sent to the City of Harbor Beach requesting production of certain public records under the *Freedom of Information Act*, MCL 15.231 et seq.
- 2. The email, sent from the account of tlambert@miopencarry.org, was signed by Tom Lambert as "President" of Michigan Open Carry, Inc.
- 3. However, the email stated that—

Pursuant to the Michigan Freedom of Information Act (FOIA), Michigan Public Act 442 of 1976; MCL 15.231 et. seq., *I* am hereby requesting an opportunity to inspect or obtain copies of public records.

- 4. Between counsels, there was an open question whether the City of Harbor Beach believed and treated the October 3, 2016 email as being from either Plaintiff Thomas Lambert or from Plaintiff Michigan Open Carry, Inc.
- 5. In Plaintiffs' Pre-Trial Statement, Plaintiffs asserted—

It is unclear whom the City of Harbor Beach deems as having made the FOIA request, Mr. Lambert or the Michigan Open Carry, Inc entity. Once that is established (discovery request pending), the other plaintiff will be voluntarily withdrawn from the suit.

6. Discovery ensured and a discovery interrogatory, dated January 16, 2017, was issued upon the City of Harbor Beach, by counsel, asking—

Does the City of Harbor Beach treat the October 3, 2016 FOIA Requests (copy attached as Exhibit A) as being from 1.) Thomas Lambert (personally); OR 2.) Michigan Open Carry, Inc; OR 3.) both.

- 7. On February 13, 2017, the City of Harbor Beach's responded, under oath, that "the request was deemed to be from Thomas Lambert, personally."
- 8. Plaintiff Michigan Open Carry, Inc and Defendant City of Harbor Beach stipulate that Plaintiff Michigan Open Carry, Inc shall be dismissed from the lawsuit with prejudice and without costs, interest, or attorney fees to, from, or between Plaintiff Michigan Open Carry, Inc and Defendant City of Harbor Beach.
- 9. This order shall not be deem an adjudication or concession as to any issue, argument, or position of any party as the remainder of the case between Plaintiff Thomas Lambert and Defendant City of Harbor Beach, including (but not limited to) whether the October 3, 2016 communication was a single FOIA request or three FOIA requests.

THEREFORE, IT IS HEREBY ORDERED that the claim(s) by Plaintiff MICHIGAN OPEN CARRY, INC, solely as to this case under the *Freedom of Information Act*, are hereby dismissed with prejudice. This dismissal shall be without costs, interest, or attorney fees to, from, or between Plaintiff MICHIGAN OPEN CARRY, INC and Defendant CITY OF HARBOR BEACH.

This is not a final order and does not close the case.
